



# Limited Warranty

Casco Industries, Inc.  
One Year Storm Product Limited Warranty

This Limited Warranty (the "Warranty") applies to storm products (the "Product") manufactured and sold by Casco Industries, Inc. ("Casco") and is provided to Casco's original purchaser only ("Purchaser"). This Warranty covers defects in materials and workmanship in the Product and is subject to the terms and conditions set forth below.

### Duration and Coverage

Limited Warranty Duration: This Warranty is effective for a period of 1 year from the date Purchaser buys the Product from Casco. Coverage: Casco warrants that the Product shall be free from defects in materials and workmanship, and will perform in accordance with the specifications provided by Casco when the Product is purchased.

### Exclusions

This Warranty does not cover:

Labor Costs: Any costs associated with labor, including but not limited to installation, removal, or reinstallation of the Product, are not covered by this Warranty. Purchaser is responsible for all labor-related expenses.

Misuse or Neglect: Damage or defects caused by misuse, neglect, accidents, improper maintenance, alteration, modification, or vandalism.

Natural Disasters: Damage caused by natural disasters, including but not limited to hurricanes, tornadoes, earthquakes, or other acts of nature.

Normal Wear and Tear: Normal wear and tear, including fading, discoloration, or deterioration over time due to exposure to environmental elements.

Improper Installation: Products that have not been properly installed are not covered under this Warranty. It is the responsibility of Purchaser to ensure that the Product is installed in accordance with the Casco's installation guidelines and industry best practices.

### Making a Warranty Claim

To make a warranty claim, Purchaser must:

File a report in writing of the alleged defect in writing within Warranty Period and provide photographs of the alleged defect with the written notice to:

When reporting a claim, include the following information:

1. Full name and address of owner
2. Provide proof of purchase, including the original sales receipt or production order number, showing the date of purchase and invoicing.

3. Full details of the problem being reports; and
4. Photographs of the defect(s).

Casco will provide further instructions after you report this information, and you may be required to allow Casco, or its authorized representative, reasonable access to inspect and evaluate the alleged defect.

### Casco's Obligations:

If a defect covered by this Warranty is verified, Casco will, at its sole discretion, either repair or replace the defective Product, or refund the purchase price paid by Purchaser for the defective Product at a prorated scale. Casco's sole and exclusive liability, and Purchaser's sole and exclusive remedy, under this Warranty is the repair, replacement, or refund as described herein.

### Limitations and Disclaimers

THESE LIMITED WARRANTIES FROM CASCO ARE YOUR SOLE AND EXCLUSIVE REMEDIES AND ARE EXPRESSLY IN LIEU OF ANY AND ALL OTHER REMEDIES, INCLUDING TORT/NEGLIGENCE THEORIES.

CONSEQUENTIAL AND INCIDENTAL DAMAGES, INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF USE, ARE NOT RECOVERABLE UNDER THIS WARRANTY OR ANY IMPLIED WARRANTIES.
